## Exhibitor Information

- Artists must be a financial member of the Gallery to exhibit.
- All work needs to be submitted to the Gallery's curatorial team for approval so that a high standard of quality work is maintained. Work will be hung at the curators' discretion and according to the overall requirements of the Gallery at the time.
- The Great Alpine Gallery Inc. retains 25% of all sales to help cover running costs. If you are prepared to work a volunteer day or more a month at the Gallery, this will be 20%. The commission is deducted from the selling price of artwork.
- Exhibitors are required to keep records in the filing box in the office listing date of delivery, title and medium of work, artist code and selling price of each item (inc commission). Work to be also labelled on the back with these details.
- Framed works are required to have D rings fixed to the back, 6cm below the top of the frame.
- An indemnity form is required to be signed by the exhibitor (see Exhibitor Agreement below).
- Work will be held at the Gallery for a maximum of 1 year to ensure a fresh presentation of artwork. Artists are encouraged to review & turn over their work regularly in consultation with the curator.
- If any member would like to propose a solo or group exhibition please contact the Gallery with your proposal. See *Hire of Exhibition Space – Application Form*.
